Single placement opportunities for AmeriCorps members engage young adults, ages 18 to 25, in natural resource, energy conservation, community outreach and emergency response work. In 2017, 17 participants served terms on special projects with a variety of land management agencies and nonprofits, and 43 served summer terms completing natural resource projects. AmeriCorps members dedicated a total 49,998 hours of service. Corps members planted 17,982 native trees and shrubs, seeded 175 acres, completed 3,124 hours of GIS data collection and mapping, collected 3,222 water quality samples, conducted 1,984 user surveys, and provided education to 6,747 people. AmeriCorps members receive a monthly stipend, health insurance, and an education award for college expenses.

The AmeriCorps field program engages young adults, ages 18 to 25, in natural resource conservation and emergency response throughout the upper Midwest. In 2017, 242 participants served in national service roles restoring habitat throughout the Midwest. Field members contributed 303,551 hours of service this year, removing invasive species and hazard trees from 13,668 acres, planting 154,409 native trees and shrubs, conducting prescribed burns on 21,557 acres of prairie, constructing or improving 468 miles of trail, installing or maintaining 744,633 square feet of rain gardens, controlling erosion on 260,885 square feet of shoreline, suppressing 114 acres of wildfire. Also, 89 AmeriCorps members spent part of their service term on natural disaster deployments helping communities recover from hurricanes in Texas, Florida, and Puerto Rico. AmeriCorps members receive a monthly stipend, health insurance, and an education award for college expenses. Beside career and work-skills training, members receive certifications in wildfire suppression, defensive driving, chainsaw safety and first aid.

Form 990, Part III, Line 4b:

The residential Summer Youth Corps engages diverse youth, ages 15-18, in environmental-restoration projects during two summer sessions, each four weeks long. In 2017, 148 youth participants, 19 AmeriCorps members, and 4 part-time staff completed 22,792 hours of environmental service-learning projects. Two-thirds of the 148 youth were from populations underrepresented in natural resources careers. In addition to natural resource work experience, they practice skills such as civic leadership and resume writing. This past year, youth crews built and maintained 85 miles of trail, managed exotic plant species on 145 acres, rehabbed 246 campsites, and engaged in 4,014 hours of training and environmental education. Participants receive a living stipend as well as room and board. Youth begin at a base camp, then "spike camp" throughout the region as they work. AmeriCorps members receive a monthly stipend, health insurance, and an education award for college expenses.

Form 990, Part III, Line 4c:

Youth Outdoors is an afterschool service-learning program for Twin Cities youth, ages 15-18 from low-income households. Youth participate for one academic semester at a time, meeting two days a week after school and on Saturdays to explore science and the environment and complete projects to improve parks and restore resources. Summer opportunities are also available. In 2017, 120 youth participants and 39 AmeriCorps members completed 39,031 hours of environmental service learning projects. This past year, Youth Outdoors participants managed exotic plant species on 329 acres of land, planted 28,684 trees and shrubs, removed 1,880 pounds of debris, and engaged in 5,026 hours of training. Youth participants earn an hourly wage. AmeriCorps members receive a monthly stipend, health insurance and an education award for college expenses. In addition to career and work-skills training, members receive certifications in wildfire suppression, defensive driving, chainsaw safety and first aid.
