There was more activity in 2017 due to hurricanes in both Texas and Florida. In addition to the \$141,030.91 in grants, the organization also made a loan of \$1,508.72 to one individual and \$5,222.88 to a different individual. These are non-interest bearing loans and the borrowers are not officers or directors of the organization.

Contributions were made to organizations providing relief to those suffering from natural disasters, primarily the hurricanes in Texas and Florida. These organizations provided benefits primarily to individuals who were not employees of Lockton Companies, Inc. and its affiliates.

The organization supported other charitable efforts. The largest dollar amount was spent to support the Adopt-A-Soldier Program. Several other charitable organizations were supported including, but not limited to Children's Mercy Hospital, Cystic Fibrosis Foundation, MS Society, Huntington's Disease Society of America, Kansas City Pet Project, March of Dimes and Pancreatic Cancer Action Network.
