Water filters are dispensed in communities where access to potable water remains a challenging task. Medical Missions - Mobile medical clinics are being established in South Africa in 9-12 townships where local missionaries have built relationships over the past 20 years. Leadership training in health promotion and disease prevention will be conducted to raise up trainers who can represent health promotion within the villages. LBIM is providing an apostolic covering/ministry oversight & administrative support for long-term medical missionaries in the field.
