For officer and key employee compensation purposes, the time requirements, responsibilities, and history/tradition of the position are taken into consideration by the governing body when determining whether a position warrants compensation. If a position does warrant compensation, the level of pay is established after reviewing the time requirements of the position, comparison to similar positions and the applicable compensation of other exempt organizations, and the review, discussion, and approval of the governing body. The entire process is documented in the contemporaneous minutes of the meeting(s) at which the compensation issue is taken under consideration.</p>
