An opinionnaire is sent to approximately 290 members each year with issues dealing with local, state and national issues. Proposed resolutions are formulated and presented at a board meeting and thoroughly debated and amended. Adopted resolutions are then supported by the voting delegate at the state policy conference. The Company's board and members then support local and state policy by contacting the representatives and lawmakers. The Company host legislative forum meetings every month to stay in touch with lawmakers. The Company board members attend meetings held at the state capital to support Farm Bureau policy. The Company meets with National representatives to discuss national issues at a regional board meeting. During the year, the Company made a local push to residents to pass LOST.

AG EDUCATION The Company is a strong supporter of agricultural education. The Company has worked very hard at keeping agricultural education in the local schools. Many schools have tried to cut ag education out of the school budget and the Company has worked diligently to keep it in the schools curriculum. The Company provides teachers from the local schools with information and materials to present to their classes. The Company awarded 6 scholarships to students attending college totalling \$3000. The Company continues to work with the local FFA Chapters to develop an AG Day for the urban elementary. The Company also sponsored the Moo U tours for the local county fair to educate fair goers about agriculture.

PUBLIC RELATIONS The Company sponsored a day at the County Fair. The Company works very closely with the Public Health Office to adopt a family in need for Christmas.
