PUBLIC POLICY The Company was very active during the year lobbying county supervisors, state legislators and congressional leaders. The Company met with the Webster County Supervisors, County Engineer and Auditor to review and scrutinize the 2017-2018 budget and lobby for additional funding for county roads/bridges. Board members met with three state legislators prior to the start of the 2017 session to lobby for Farm Bureau policy in addition to several more meetings throughout the entire legislative session. The County Board President & Voting Delegate attended the American Farm Bureau Annual Meeting to lobby for the best interests for national agricultural policy (\$2,500). The Company Treasurer traveled to Washington DC to lobby our state senators and representative regarding agricultural issues (\$1,473). The Company also hosted an annual meeting for its 2,154 members where the attendees were given the opportunity to elect the board of directors and review the prior year audited financial statements at a cost of \$3,926.

EDUCATION/AG IN THE CLASSROOM The Company helped sponsor a four county-wide 5th grade Youth Environmental Days at the Wright County Fairgrounds in Eagle Grove, Iowa. Approximately 800 students attended one of the four-day event where they learned about by-products that come from corn/soybeans, farm-to-market, farmers feeding the world along with four other 45 minute breakout sessions (\$250). The county Ag In The Classroom Coordinator also provided a series of agricultural breakout sessions to 500+ students at the Prairie Valley and St Edmunds school districts. These sessions were taught over a three day period of time (\$699). The Company also donated \$200 to the Webster County 4-H Foundation and provided 2-\$500 college scholarships to graduating Farm Bureau members seniors and 2-\$1,000 scholarships to Iowa Central Community College Ag students.

AGRICULTURAL PROMOTION The Company was a corporate sponsor for a 2 day Farm News Ag Show held in Fort Dodge, Iowa that was attended by over 2,000 local farmers (\$1,250) and also for the Dayton Rodeo where over 3,000 people attended the 3 day event (\$2,500). The Company donated money to help support/promote the Webster County Fair. The Company provided free watermelon/sweet corn to fair attendees, sponsored the Kiddie Tractor Pull, donated wood chips for 4-H/FFA exhibitors and trophies (\$3,270). The Company promoted the livestock industry with a 60 second "Livestock Matters" video that was shown at a local movie theater for 4 weeks (\$1,455). The Company also conducts a \$300 shopping spree to promote Ag Week in March. While the shopping spree is taking place, 5 board members are on the radio informing the listening audience (5,000+) about the significant role agriculture plays in their daily lives (\$1,377). The Company donated funds to the Humane Society of North Central Iowa for micro-chipping (\$1,952).
