PUBLIC POLICY Activities were conducted locally within the county. The annual meeting was September 13 with 268 members attending. Accomplishments for the year were reviewed to those in attendance, election of officers and directors occurred along with the surfacing of issues the Company should engage in. Suggestions included Johnson County's poor farm preservation, diversification into non-traditional forms of agriculture and allowing rural Johnson County to secede and join different counties were some of the 24 issues raised by members. The issues were exchanged at a regional policy development meeting held in November. Members met with the county supervisors and county engineer personnel regarding the various county issues and are involved in the county comprehensive planning committee throughout the year.

AGRICULTURAL PROMOTIONS The Company's main event to inform the general public of the importance of agriculture occurs at the Johnson County Fair held in July. This occurs with the operation of the Heritage Barn. The Heritage Barn is staffed by volunteers during the fair and showcases demonstrations ranging from wool spinning to ice cream making as well as operation of a petting zoo. Locally grown vegetable samples were provided along with container garden plots. The main stage in the center of the fairgrounds where all the events are either conducted or broadcast from is sponsored by the Company.

AG EDUCATION The Company places great emphasis on educating tomorrow's leaders especially those pursuing a career in agriculture. The Company provides scholarships to youths of members that are pursuing a college education. The youths complete applications and attend interviews with the scholarship committee. Four scholarships were awarded totalling \$3,000 during the year.
