THE FRIENDS LOANED AN ADDITIONAL \$79,000 TO THE IOWA NATURAL HERITAGE FOUNDATION (INHF) FOR THE PURCHASE OF A 47 ACRE IN-HOLDING AT THE REFUGE. THIS IS IN ADDITION TO A \$81,000 LOAN IN 2015 AND \$79,000 IN 2016 FOR THE SAME PROJECT. AN ADDITIONAL LOAN IN 2018 FOR \$79,000 WILL ENABLE THE INHF TO COMPLETE THE PURCHASE. UPON EXPECTED SALE TO THE USFWS PROCEEDS, LESS COSTS INCURRED, WILL BE USED TO RETIRE THE LOAN. THIS IS LESS THAN AN "ARMS LENGTH" TRANSACTION AS BOTH THE INHF AND THE FRIENDS SHARE AN OBJECTIVE OF FACILITATING THE SALE OF PRIVATE LAND IN-HOLDINGS AT THE REFUGE FROM WILLING SELLERS TO THE USFWS.

PART VI. THERE ARE APPROXIMATELY 200 MEMBERS. MONTHLY MEETINGS ARE OPEN TO THE PUBLIC. MINUTES ARE AVAILABLE TO ANYONE UPON REQUEST. ANNUAL BUDGETS ARE PREPARED AT THE BEGINNING OF THE CALENDAR YEAR AND AMENDED AS NEEDED.

THE WHISTLE BLOWER AND OTHER POLICIES ARE REVIEWED PERIODICALLY. FINANCIAL STATEMENTS ARE KEPT ON A "CASH" BASIS. TRANSACTIONS ARE DOCUMENTED WITH INVOICES, CHECKS, OR ELECTRONIC EQUIVALENTS. ALL RECEIPTS ARE DEPOSITED INTACT. AND INVESTMENT BALANCES ARE PROVIDED TO BOARD MEMBERS MONTHLY. THE ONLY CASH MAINTAINED AT THE REFUGE IS A \$200 CHANGE FUND. THERE WERE NO DONATIONS OVER \$5,000; THUS A SCHEDULE B IS NOT REQUIRED. THE RELATIVELY LARGE CASH AND INVESTMENT AMOUNTS RESULT FROM A SUBSTANTIAL BEQUEST IN 2006. THE BOARD'S VISION IS THAT MOST OF THIS BEQUEST SHOULD BE USED TO FACILITATE LAND PURCHASES WITHIN THE REFUGE BOUNDARY FROM WILLING SELLERS; ANTICIPATING SUBSEQUENT SALE TO THE USFWS. INITIALLY, THE FRIENDS LOANED \$1,500,000 TO THE IOWA NATURAL HERITAGE FOUNDATION (INHF) TO ASSIST WITH A 840 ACRE IN-HOLDING PURCHASE. AN ADDITIONAL 47 ACRE TRACT WAS PURCHASED BY THE INHF IN 2015 FOR \$318,000. THE FRIENDS LOANED INHF \$81,000 IN 2015, \$79,000 IN 2016, \$79,000 IN 2017 AND EXPECT TO LOAN \$79,000 IN 2018 TO COMPLETE THIS PURCHASE OF THE 47 ACRE TRACT. THESE ARE NOT "ARM'S LENGTH" TRANSACTIONS. UPON SALE OF THESE TRACTS TO THE USFWS, THE PROCEEDS, LESS INHF MANAGEMENT COSTS, WILL BE RETURNED TO THE FRIENDS TO FACILITATE ADDITIONAL TRANSACTIONS. IN 2017, INHF DEED AN UNDIVIDED INTEREST IN A 321 ACRE PORTION OF THE 840 TRACT TO THE FRIENDS. THIS INTEREST WAS VALUED AT \$250,000, REDUCING THE LOAN TO THE INHF BY THAT AMOUNT. THIS 321 ACRE ACQUISITION RESULTS IN THE FRIENDS BEING ELIGIBLE FOR CONSERVATION PAYMENTS (CRP), \$37,250 IN 2017, REPORTED AS PROGRAM INCOME. THIS IS REPORTED AS "RELATED" BUSINESS INCOME, THUS NOT TAXABLE INCOME. A NATIONAL FISH AND WILDLIFE FOUNDATION (NFWF) GRANT SUPPORTS PRAIRIE RELATED CONSERVATION ACTIVITIES OUTSIDE OF THE REFUGE. \$51,081 WAS RECEIVED FROM NFWF FOR THIS PROGRAM. NO OTHER SIGNIFICANT PROGRAM CHANGES OCCURRED IN 2017. A COPY OF THE FRIENDS' BALANCE SHEETS, STATEMENTS OF ACTIVITIES AND RELATED NOTES FOR THE YEARS 2013-2017 ARE APPENDED TO FACILITATE FURTHER EXAMINATION.
