The IWF committed to a new 5-year plan to grow its impact, resources and capacity to shatter the six barriers to women's economic success in Iowa. We narrowed our focus, so we could increase our impact and focused our work on increasing women's economic self-sufficiency and participation in the work force by ensuring access to affordable quality child care. Strategies included grantmaking, community collaborations, advocacy and entrepreneurship. We targeted our grantmaking and committed to raising public awareness, fostering advocacy and building a voice based on authentic research that tells the story of women and girls in Iowa. Through social media, (website, Facebook, and twitter), newsletters and community visits/presentations, the IWF is providing Iowa data and stories related to the barriers women and girls face to economic self-sufficiency. The IWF produced 1,500 copies of the 5th edition of ovation - a tribute to Iowa's women and girls and hosted events in cedar rapids, davenport, Des Moines, and waterloo celebrating the honorees and sharing the work of IWF.

Grantmaking is the heart of the IWF. In 2017, IWF hosted four community information sessions around the state and awarded 15 grants totaling \$92,606 through its core grantmaking program. The grants support organizations across Iowa reaching all 99 counties serving 407 girls and 850 women. The programs are ensuring women in communities across Iowa will have safe and reliable childcare available, so they can pursue their educational goals or employment.
