Gather CHNA data from secondary sources, obtain input from stakeholders representing the broad interests of the community through interviews and focus groups, use data to select top health priorities, and complete written CHNA. * Develop, adopt, and implement strategies to address top-health priorities. Establish strategies to address priorities, complete Strategic Implementation Plan, obtain Regional/Divisional Board approval, and integrate strategies into operational plan. * Make CHNA widely available to the public. Publish CHNA and summary document on hospital's website. * Monitor, track, and report progress on top health priorities. Collect data and evaluate progress, report to Regional/Divisional Board every six months and System Board every year, share findings with community stakeholders, and send results to finance for submission to the Internal Revenue Service (IRS). CBISA is the gathering, collecting, and reporting of all data relating to community benefit activities and programs across the System. A CBISA is conducted every year by each hospital according to the following steps: * Collect and enter data. Send out emails reminding staff to submit activities, enter data into Lyon, and run reports to share with leaders. * Finalize and report on prior year. Enter all prior year data into Lyon by January 31, and communicate final prior year figures to IRS, System Board, and the community. System Office staff and leaders oversee and monitor SSMH's Community Benefit Program, and ensure reporting is in compliance with IRS regulations. In collaboration with community stakeholders and partner organizations, SSM Health Care Corporation also identifies needs based on assessments and research, and SSMH facilities also involve case managers and care team staff to pinpoint critical health issues in the community. All hospital CHNAs are completed, approved, and integrated into the organization's strategic plan. We continue to monitor and assess the progress of our local efforts in the spirit of caring for others and improving community health.

While SSM Health Good Samaritan Hospital - Mt Vernon is not equipped to address all the influencing factors, the hospital is able to assist in providing cancer treatment options and promoting healthy lifestyle practices that are highly conducive to preventing the development of cancer. The following goals were in place in 2017 to address cancer issues - Goal Reduce the Jefferson County age-adjusted death rate due to cancer from 203.1 deaths per 100,000 persons reported in 2015 to 195.8 deaths per 100,000 persons by 2018 (close the gap between county and national rate by 25%), the death rate due to cancer decreased to 194.2 per 100,000 in 2017 - Goal Reduce the percentage of initial cancer diagnoses that are late stage (III and IV) for lung, prostate and colorectal cancer, from 58% in 2014 to less than 48% by 2018 (breast cancer with a late stage rate of less than 15%). The SSM Health Good Samaritan Hospital - Mt Vernon 2016 - 2018 CHNA showed heart disease as a top health concern for the community. Heart disease is affected by numerous lifestyle behaviors including smoking, uncontrolled blood pressure and cholesterol, diabetes, stress and depression, an unhealthy diet and lack of exercise. SSM Health and SSM Health Good Samaritan Hospital - Mt Vernon offer a wide scope of programs with the goal of creating healthy lifestyle behaviors and reducing the risk of heart disease in the community.
