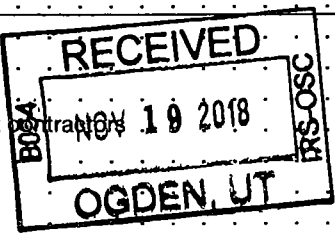



Our educational programs include a year-round community arts program for at-risk youth including African-American and immigrant/refugee youth in addition to a variety of educational programs for the community at-large. On occasion we use other arts mediums to nurture cross-cultural understanding and acceptance such as poetry, photographic exhibits and conferences.

The mission of Gitana is to use arts and education as vehicles for community engagement and cross-cultural understanding that would highlight our similarities and differences as people of diverse world views.
