The TEARS Foundation offers free support groups, individual peer companions, memorial events and onsite bereavement centers with resources for the community and bereaved families who have experienced the death of their child.

Two bereavement centers offered onsite support, community awareness, and training for professionals.

Over 8,500 individuals have received support through these services.
