Memory Trees designs, creates and manages programs that disrupt dependencies on social benefit programs, delivering better access to resources for health. The NGO has a laser-like focus on using sustainable food as a foundation to create community hubs. To achieve this, Memory Trees delivers socially responsible landscaping services, employs people with unique abilities, manages vocational rehabilitation facilities, builds urban farms and community gardens, and delivers ongoing hands-on educational workshops covering diverse topics.
