We also work on plastic pollution and have engaged with more youth organizations.

Regulation of high seas - the discussions regarding regulation continue to move through the UN process and high-level meetings will occur in September 2018. We expect to engage global leaders in these conversations as the decisions made in September will be critical to the protection of the high seas in the future. We are working to include these discussions in the G7 meetings in Canada this year (June and September).

Marine Protected Areas - MPAs - We continue to work with countries around the world in an effort to create or significantly expand existing MPAs. This year we have seen progress in Chile, Mexico, and Pacific Island Nations. MPAs are critical as areas of refuge and regeneration, enabling fish and other ocean wildlife to breed and mature in safe areas. We expect to continue our work with many countries this year including Canada, Spain, and Cuba.

Species protection - This covers many areas including coral, shark finning, destructive fishing practices, tuna depletion, whales, and other broad areas where specific species or ecosystems are under threat.
