Part III - Line 2. Prior to 2017, a separate organization called Seeds of Hope raised money for both Wildwood Soup Kitchen (WSK) and Wildwood Food Pantry (WFP) by holding concerts, a pancake breakfast, and food drives at local grocery stores. Each March, they would donate half of the money to each organization. They were small and inactive for much of the year, so they used the WSK checking account to hold their money during the year. WSK would regard the half of the money owed to WFP as a liability and report it as such on its tax return each year. It was decided that on January 1st, 2017, Seeds of Hope would become part of WSK. We took over their assets of \$27,856 on that day (reported on Part I, line 11 as "other revenue"), and beginning this year and in future years all Seeds of Hope funds raised would be included as income to WSK, and WSK would donate half of that amount to WFP (reported on Schedule 1). Another reason this was done is that checks were being written to "Seeds of Hope", so WSK would sometimes have trouble getting the bank to accept these checks. A fictitious name "Seeds of Hope" was set up to solve this problem. In essence, Seeds of Hope is now the fundraising committee of WSK. This fundraising is the new program service that was not listed on prior returns.
