As an independent nonprofit organization, Bay Area Lyme is able to partner with leading researchers and institutions all across the country to support the most innovative and promising projects in Lyme disease research, regardless of affiliation. True breakthroughs will occur only through well-designed research projects and at Bay Area Lyme, we have a rigorous screening and monitoring process, grant contingencies, and project reporting, to ensure that projects are effectively designed and funds well spent. In 2017, Bay Area Lyme Foundation funded 17 grants, 1 program related investment and 1 sponsorship to various institutions across the country. Funding for new diagnostic projects included a \$250,000 grant to Harvard University which is developing a paper-based diagnostic tool to detect early Lyme infections. New treatment research projects included a clinical genomic study of Lyme and novel causes of Lyme-like Illness at the Broad Institute. Three ecology grants focused on tick studies in specific regions of the U.S. as well as the ongoing funding of the Citizen Science Tick Testing project that generated a nationwide participation from the public for most of 2017. The second and final sponsorship of the HackLyme event held in the fall of 2017 aimed to provide a forum for students, scientists and business people to use next-gen technologies, science, and innovation to deliver solutions for tick borne illness.

Form 990, Part III, Line 4b:

Bay Area Lyme offers free in-service education and training regarding tick-bite prevention to residential outdoor schools, outdoor environmental education, and professional outdoor program/field trip providers on-site. Bay Area Lyme is partnering with the Association of Environmental and Outdoor Educators (AEOE) to offer education and training to the professional naturalist community who teach children in the 130 residential outdoor science schools throughout California. School-age children are particularly susceptible to contracting Lyme and other tick-borne illnesses. Because of our educational outreach program, outdoor education teachers are now instructing children to check themselves for ticks daily and are learning the correct steps to take if they get bitten. The in-service ensures that adults working at outdoor school facilities know how to protect themselves against Lyme and tick-borne diseases, and enhances the safety of teachers and students. This program is relevant for naturalists, outdoor educators and teachers, park rangers, outdoor sport and recreation instructors, docents, EMTs, first aid providers, firefighters, volunteers and anyone who is working in a position of responsibility for the health and safety of others in the outdoors.
