Western Native Voice is a nonprofit, nonpartisan, social justice organization working to inspire Native American leadership so our communities flourish. We foster positive social change through leadership, engagement, education, and advocacy.

Community Building and Engagement We hosted community forums in multiple locations across Montana to bring together local leaders and community members and discuss issues of importance to Montana's Native communities. One of the issues raised during these community forums was the prohibition of native regalia at public ceremonies like graduation. We advocated for legislation that would formally allow native regalia at graduations and it passed during the 2017 session. We attended pow wow's and tribal college events across Montana and connected with students and community members on issues related to social justice and public policies that affect their daily lives. We participated in regional discussions related to diversity, equity, and inclusion. We are working to increase the level of inclusion of diverse cultures in the workplace and social fabric to increase opportunities for collaboration and participation for all.

4b (Code:) (Expenses \$ 92,555 including grants of \$) (Revenue \$)
Leadership Development: We engaged with groups across the country to create leadership development and training opportunities. We co-hosted the Indigenous Movements Interchange which brought together members of Indigenous populations in Montana to find common ground, support, and opportunities to collaborate on shared issues. We also participated in, and presented at, various conferences throughout the year and shared our experiences and what we have learned through our polling, canvassing, and direct engagement work in Montana's Native communities. Many youths who have participated in our leadership development programs have advanced to leadership roles like tribal council, TERO (Tribal Employment Resource Office) Boards, and governance positions with other nonprofit organizations.

4c (Code:) (Expenses \$ 93,179 including grants of \$) (Revenue \$)
Civic Participation: We trained and supervised a staff of community organizers who worked in their local communities to educate local voters on the special election process. They also worked to help eligible voters register to vote and make arrangements to reach the polls. During Montana's legislative session, we kept our audience informed on the status and progress of proposed legislation of interest to Native voters. We hosted a Native Day of Action in which we helped Native Americans from across Montana travel to Helena to meet with legislators directly and discuss issues of importance to their communities. We helped community members prepare testimony on proposed legislation. We used social media and other tools to inform our members of opportunities to participate in the public policy process. We disseminated complicated information in a clear and relevant way to our members so that they were able to make the connection between the public process and the affects that can be felt in their daily lives. In the process, we inspired members to take action and feel like they belong in the public conversation.
