The Step Ahead program operates through a model of individual assistance and aims to take a comprehensive approach to ending poverty. Social workers, lawyers, psychologists, teachers and support staff work together to support 280 disadvantaged children. In 2017, this support includes \$13,366 for nutrition and health, \$42,726 for two shelters, \$14,000 on long-term support, \$4,294 for the Drop-in Center, \$102,537 for emergency support, \$2,040 for children with disabilities, \$37,404 for Youth engagement.

4b (Code: SIS) (Expenses \$ 22557 including grants of \$ 22557) (Revenue \$ _____)

Stay in School is a program providing support to children in Bac Ninh Province at high risk of dropping out of school or who have recently quit due to poverty. There are 277 children in the program. Support includes school fees, bicycle and medical insurance.

4c (Code: SAS) (Expenses \$ 107616 including grants of \$ 107616) (Revenue \$ _____)

Safe and Sound is an antitrafficking program in Hue and Dien Bien Provinces. In 2017, Blue Dragon rescued 166 from forced labor or sexual slavery. There are 469 victims who received benefits from the Safe and Sound program, including medical assistance, counselling, vocational training or assistance in returning to school.
