ONE OF COMPASSION CHILD CARE'S CORE VALUES IS BEING AN EDUCATIONAL BASED DAYCARE. INDIVIDUAL READING OPPORTUNITIES WERE GIVEN TO EACH CHILD IN THE DAYCARE. THEY WERE READ TO INDIVIDUALLY DURING THE WEEK BY VOLUNTEERS AND STAFF. THIS READING IS A CRITICAL STEP TOWARDS HELPING CHILDREN BE PREPARED FOR LEARNING IN KINDERGARTEN. WE OFFERED A CASE MANAGEMENT PROGRAM CALLED PIVOT. THIS PROGRAM WAS OFFERED TO ANYONE WHO HAD CHILDREN ENROLLED IN THE COMPASSION CHILD CARE DAYCARE. THIS PROGRAM CONSISTED OF THIRTEEN FAMILIES WORKING WITH A CASE MANAGER FROM CCC. THE CASE MANAGER MET MONTHLY WITH EACH FAMILY TO HELP DEVELOP BUDGETING SKILLS AND LEARN CONSISTENT FINANCIAL MANAGEMENT. THE CASE MANAGER HELPED THE FAMILIES DEVELOP GOOD DECISION MAKING SKILLS. THE FAMILIES RECEIVED INCENTIVES EACH QUARTER FOR THE WORK THEY COMPLETED. THOSE INCENTIVES WENT TOWARDS OUTSTANDING DEBTS. IN ADDITION TO PAYING OFF DEBT, THE FAMILIES IMPROVED THEIR CIRCUMSTANCES THROUGH JOB UPGRADES OR PROMOTIONS AT THEIR CURRENT EMPLOYMENT. EIGHT OF THE THIRTEEN FAMILIES PARTICIPATING SAW POSITIVE IMPROVEMENT IN THEIR OVERALL CIRCUMSTANCES INCLUDING FINANCIAL, EMOTIONAL, AND SPIRITUAL. THEY RECEIVED HOUSING ASSISTANCE AND OTHER FORMS OF INCENTIVE TO COMPLETE GOALS THEY DEVELOPED WITH THEIR COACH.
