CFC vigilantly advertised its mission across the state of Arkansas, via radio sponsorship advertisements, as well advocating its mission of educating the Arkansas public via social media. Also, CFC created and distributed a "scorecard" of the Arkansas General Assembly during its legislative session in 2017. With this "scorecard", CFC made it possible for a given member of the public to look at their state legislator's voting record in the 2017 General Assembly, and have it "scored" based on the principles listed in CFC's Mission.
