Stork BusesSave the Storks exists to partner with pregnancy resource centers and give abortion-vulnerable women a choice that will change their lives forever. We come alongside pregnancy resource centers all over the nation, providing them with powerful tools and training to more effectively connect with those women in their communities. With the support of donors, and in conjunction with our affiliate pregnancy resource centers, we have built Stork Buses (mobile medical units) that reach women near abortion clinics, on college campuses, in rural areas and inner cities. (continued on Schedule O)Save the Storks believes that going mobile is one of the most effective strategies for reaching abortion-vulnerable mothers. We've seen Stork Buses profoundly expand the reach and increase the impact of pregnancy resource centers all over the nation. These mobile medical units minimize the distance between the PRC and the women most in need of the services. The first year we had a Stork Bus on the road, we saw 394 women make a decision for life for their babies. In 2017, four out of five women who boarded a Stork Bus, saw their baby on the ultrasound and heard the heartbeat, chose life, according to reports provided by participating affiliate PRCs. We signed seven new pregnancy resource center affiliates in 2017, delivered 10 Stork Buses and ended 2017 with a total of 33 Stork Buses at our affiliate PRCs.

Form 990, Part III, Line 4b:

AwarenessSave the Storks continued to advance the pro-life movement in 2017 with intentional communications focused on awareness. The organization launched and nurtured a robust social media campaign that saw a marked increase in followers, most notably 41,420 new followers gained on Facebook, a 23% increase with a total of 221,510 followers as of December 31, 2017. The organization's ministry efforts were featured on LiveAction, Samaritan Ministries, Dr. Dobson Ministries and Crux. Save the Storks also participated in the 2017 March for Life. Videos that engaged viewers while informing them about the pro-life movement were distributed throughout the year, with (continued on Schedule O) a Father's Day. Save the Storks invested in several initiatives in 2017, including the Voiceless Church Tour, Heartbeat, CareNet and The Sparrow Conference, Christian music tours (Plumb 2017), Summit Ministries (their mission is to cultivate rising generations to resolutely champion a biblical worldview), and The Remnant Generation, a Uganda pro-life ministries that supports unwed mothers and their babies, ensures they are educated and have their healthcare needs provided.

Form 990, Part III, Line 4c:

Stork Works Consulting In 2017, Stork Works Consulting conducted 16 trainings or consultations for pregnancy resource centers and life-minded organizations. Of those, 16 were given grants to supplement the cost of the training. Eleven of the trainings were specific to mobile ministry, and two focused on strategic planning. Two trainings were related to adding ultrasound services and one was a sidewalk counseling training. At the end of 2017 we began planning for the expansion of the consulting/training division of Save the Storks to include our first annual Intensive Conference in 2018. (continued on Schedule O) Adding Ultrasound training takes a non-medical pregnancy center through the process of the addition of ultrasound services. We walk them through the legalities, policy and procedures, and who and how to hire for professional medical services. ABCs of Going Mobile training equips centers with the ability to run a successful mobile ministry. We spend 1-5 days on-site at the center teaching them when and where to park their mobile unit, the unique aspects of mobile ministry, fundraising techniques, and important aspects for thriving in mobile ministry. StratOp is a 3-day on-site strategic planning consultation designed to effectively implement long-term strategic goals and current operational strategies for pregnancy centers. This is done with the board and Executive Staff.

In just four months, this Stork Bus served 24 clients, and 16 of these clients chose life for their baby. Stork Bus Testimonials November 2017 On a cold November morning our Stork Bus was parked outside the late term abortion clinic in New Mexico. The parking lot was full of out of town license plates. A truck pulled in with Colorado plates. A young girl got out of the car with an older couple. They all looked scared and confused. She spoke with someone from the PRC there on the sidewalk and agreed to come over and talk with the staff on the bus before their abortion appointment. We welcomed them in to the warm bus and asked them to tell us their story. The young girl (Missy) was pregnant and in her second trimester. Missy was a 15 years old high school sophomore. She was with her parents. They had taken her to Mexico to get an ultrasound and now were here in New Mexico for her abortion. She began to share how scared she was about being pregnant. She said she wanted to finish high school. Missy also shared that the baby's Dad wasn't involved. As she talked she relaxed a little and began to smile as the staff asked questions. One of the staff members asked if she could share her experience with the family and they said yes. The staff member shared that she had just retired after 30 years as an Engineer. But 40 years ago she was facing the same decision as Missy. She was 15 and pregnant. She kept her baby and went to a school for pregnant teens. She went to college and had had a good career and an amazing family. She shared about her children and grandchildren she had because of that choice. She told Missy "It won't be easy but it will be amazing." Missy and her parents were encouraged and asked a lot of questions about school and pregnancy. The staff also began to show the

ORGANIZATIONAL MISSION STATEMENT (continued)	family information about fetal development and what Missy's baby was doing at that moment Missy shared that she had seen the baby sucking its thumb during her Ultrasound in Mexico Missy's parent told her they would chose life for their grandchild but it was her decision Missy said she wanted to keep the baby and stay in school but she was nervous about the baby not having a father figure When she said that, her Dad came over and took her hand and said I will be that man in your child's life She began to cry (so did some of the staff) Missy said "I want to keep the baby" Her parents were very excited We all prayed together then we gave the family contact information for local pregnancy centers in their area so they would have support when they got home They thanked the staff and advocates and began their long trip home God has a purpose and a plan He put the right people in the right place so Missy could hear what she needed to hear to choose life July 2017 "July" is a 28 year old single woman who was abortion vulnerable and came by herself to our MMV for an ultrasound "July" had a history of miscarriage and was definitely leaning towards abortion and categorized herself as "undecided" before the ultrasound scan She shared with our MMV nurse that she had relationship concerns with the father of the baby which contributed to her being vulnerable to abortion Upon seeing her 6w2d fetus and the baby's beating heart she changed her mind and decided to carry Due to the impact of the ultrasound, seeing that the baby was alive on the screen, and learning about the baby's development, "July" decided to carry her baby She verbalized that she will carry even if the father of the baby is not present or supportive Stork Bus Testimonials (continued) April 2017 The Stork Bus/Medical Mobile Unit arrived early on Friday morning to set up for a health fair Once the unit was set up and open for clients and interested community members there was a steady flow of people on the bus The staff notice a young lady that kept walking by the bus but not coming in A staff member went and talked to her They explained our services and gave her information She still seemed reluctant to say much so, they invited her on the bus and began to speak to her privately She said she thought she needed a pregnancy test She shared with them that she had been living as a lesbian but had recently met a man and was re-thinking her choices They did the test and it was positive She was scared and confused They asked her if she would like to have an ultrasound She said yes The baby was beautiful Moving and waving arms The client began to cry and share her fears The staff was able to comfort her and provide her with resources They shared God's story of love with her She listened intently They asked if she would like to accept Jesus into her heart and she said yes! They prayed with her and made a follow up appointment at the local Care Net office She has devel

ORGANIZATIONAL MISSION STATEMENT (continued)	oped a bond with the members that led her to Lord and still visits them at Care Net February 2017 Jamie* had a positive pregnancy test at home and was immediately panicked She had driven by Heartbeat of Toledo's Your First Look mobile unit one time before, but was in shock that she could be pregnant and chose to keep driving Jamie decided she wanted to visit our mobile unit the following week She told the advocate, "I hate this already I can't keep it I already have other kids and can't support another one And, adoption is not an option " Jamie hoped for a miscarriage as she was fearful of the physical ramifications of an abortion On the mobile unit we were able to provide her with education on all of her options and a glimpse into what was going on inside her body The ultrasound showed that she was 7 weeks 3 days and the baby had a strong heartbeat While she requested pictures , Jamie had little emotional response to anything she saw We scheduled a follow-up appointment with her at one of our brick and mortar locations for the following week Jamie did not show up for this appointment and despite attempts to reschedule her, did not return until about a month after her initial appointment with us When Jamie came in for her follow-up appointment at Heartbeat, she told us she had an abortion scheduled for the same day in Michigan and once again said, "I don't want it (the baby) " The only reason she didn't attend that abortion appointment was because she did not complete the required paperwork in time As the Heartbeat advocate processed seeing the ultrasound with her and asked how she was feeling, Jamie said "I don't know now, it's a real baby," but was still considering abortion A week later Jamie returned for another follow-up appointment and had a complete demeanor change As she thought back to her previous appointments with us and seeing the ultrasound she decided she didn't want to follow through with the abortion that she had scheduled Also, in working through the information she received from us she determined that she wanted to pursue adoption As of today (3/23), Jamie has chosen an adoption agency and an adoptive family and met the family for the first time in our offices It is stories like Jamie's that make us thankful for the work God has called us to through Heartbeat In closing, Save the Storks will continue to take innovative steps to promote the pro-life movement Funds raised will be used for relevant communication channels to elevate the conversation and share the truth with love, compassion and action Together with our supporters , donors and prayer partners, we are confident that abortion will soon be unthinkable, and that every human being will agree that denying babies life is as atrocious as the Holocaust and slavery
