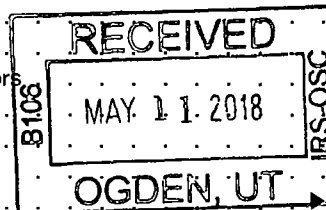

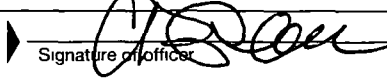

Money from the US bank account of S&R Ministries, Inc. to the Christ for India Mission Society, an organization duly registered with the Indian Federal Government and the State of Andrah Pradesh as a humanitarian work and certified to receive foreign contributions, under the direction of Sudhakar Rao; providing over 95% financial support for giving complete care for about 80 orphan children including food, board, medical needs, health needs, school needs, tuition, clothes; providing housing and food for about 50 widows and aged men who have no other place to go, providing a livelihood of sewing for widows and poor women, providing training in remote villages in education and life improvement; leaving books behind when financially possible. The money is granted to the CIMS for educational purposes and humanitarian work. [Grants in 2017 = \$44305]

Money from the US bank account of S&R Ministries, Inc. sent to the Tinturn Church of Christ in Ontario to go toward "Tinturn Asia Mission" work in orphanages and schools for education of children in Japan and Cambodia. [Grants in 2017 = \$46779]
