1. THE ZUPETZ FAMILY HAD SIGNIFICANT HEALTH CHALLENGES STEMMING FROM HEATHER'S PAST KIDNEY TRANSPLANT AND SIDE EFFECTS FROM HER MEDS, WHICH SERIOUSLY IMPACTED THEIR ABILITY TO PULL THE INFORMATION TOGETHER.
2. THEY ALSO HAVE BEEN SEEKING TREATMENT FROM SPECIALISTS FOR THEIR SON DANIEL, WHO WAS DIAGNOSED WITH AUTISM. HE HAS MANY PHYSICAL AND EMOTIONAL NEEDS DUE TO HIS CONDITION.
3. FROM 2015 UNTIL THE END OF 2017, THEY WERE DEALING WITH THE STRESS FROM THE LEGAL INVESTIGATION OF A COMPANY THAT HAD BEEN A MAJOR DONOR. THERE WAS A LOT OF LEGAL/FINANCIAL PAPERWORK THAT HAD TO BE PREPARED FOR THAT. THIS TOOK AN IMMENSE TOLL ON THEIR FAMILY - PHYSICALLY, EMOTIONALLY, AND FINANCIALLY. IT ALSO NEGATIVELY IMPACTED Z MINISTRIES DUE TO LACK OF RESOURCES AND HAVING TO LET GO THE ENTIRE OFFICE STAFF AT THE END OF 2015, INCLUDING THE BOOKKEEPER WHO PULLED THE INFORMATION TOGETHER FOR 990 RETURNS IN PRIOR YEARS.
