The Friends of the Half Moon is a 501 (c)(3) educational organization that helps to support a full-size replica of Henry Hudson's 17th century flagship **de Halve Maen (Half Moon)**. It was Hudson's voyage in the **Half Moon** in 1609 that led to the first European settlements in what would later become the State of New York. The replica ship was constructed in Albany, NY in 1989 and has represented the State of New York for over 25 years in maritime festivals and events.

In 2009, The State of New York celebrated its 400th Anniversary. The celebration centered around New York's Dutch origins following Henry Hudson's voyage for the Dutch East India Company (VOC) in the **de Halve Maen (Half Moon)** in 1609. The celebration was covered by world-wide press and was hosted by the Dutch Royal Family, Mayor Michael Bloomberg, and Secretary of State Hillary Clinton.

Since April 2015, the **Half Moon** has been in the Netherlands under a partnership agreement with the Westfries Museum in the City of Hoorn, The Netherlands. For the past three tax years, 2015, 2016, and 2017, our non-profit organization could not raise funds in the United States since the **Half Moon** was in the Netherlands. We were also under contract with the Westfries Museum not to interfere with their fund raising efforts.
