**In 2017, our most critical metrics - net impact (money moved minus money spent) and money moved (relative to money spent) - grew approximately 40% over 2016. We achieved a net impact of approximately \$3.4 million and a ratio of money moved to money spent of about 13:1. Our team is also pleased that our worldwide audience is now ten times what it was in 2013 when we formally began. This all represents real progress as we seek to grow and expand The Life You Can Save. However, to bring TLYCS to scale, we will need to attract more funders that see the enormous opportunity our Leverage Model offers in the battle against extreme poverty.**
