- Holding 36 legal clinics where we advised over 400 local nonprofits and low-income entrepreneurs  
- Researched, wrote about, and advocated for laws and regulations supporting worker cooperatives and community energy  
- Developed materials and taught workshops on workplace democracy in nonprofits  
- Held over 60 educational events, workshops, and webinars  
- Provided mentorship and training to over 20 lawyers from across the nation who are building their own legal organizations focused on creating more sustainable economies  
- Provided extensive technical and legal support to two new cooperatives, one focused on community-owned affordable housing, and the other focused on community-owned renewable energy  
- Researched and taught about laws governing community-based compost organizations

The organization was managed by all 15 employees, none of whom meet the definition of a "key employee," because none of them made more than \$150,000. All staff receive equal salaries and are expected to participate equally in the management of the organization, under a staff governance structure that ensures a high level of integrity and accountability. Management includes tasks such as facilitating bookkeeping, budgeting, managing insurance, recordkeeping, coordinating hiring and training, contact management, newsletters, website management, and other administrative functions. The directors provide substantial oversight over management activities of the staff.

Three staff worked closely with our bookkeeper and accountant to ensure that we have all necessary financial information to prepare the 990. After preparing a draft of the 990, the three staff worked together to review our responses against the instructions, and cross-check all of the numbers we input. The draft was provided to the Board of Directors, and staff incorporated feedback from the Board.

We keep track of all organizations and businesses in which directors, officers, and staff members have an interest. When directors, officers, or staff are contemplating a transaction with an interested person, or with an entity that they are members or owners of, we carefully follow the procedures in our conflict of interest policy, which includes deliberating about the matter, exploring alternatives, and voting on the matter without the interested party present. Conflicts of interest are generally identified and reviewed by the Board, however, an independent team of staff members also reviews conflicts of interest that arise at the staff level.

All staff earn equal salaries that are set with reference to the MIT Living Wage Index. All staff members earn the same salary, regardless of role or length of tenure with the organization. All staff are involved in salary discussions. Any changes in the salary must first be presented at an all-staff meeting, approved by every staff member of the organization, and then sent to the Board for review. The Board of Directors then deliberates on the matter and examines the basis of the current living wage calculations before approving any change. All staff currently make salaries that are far below market rates for similarly situated nonprofit employees.
