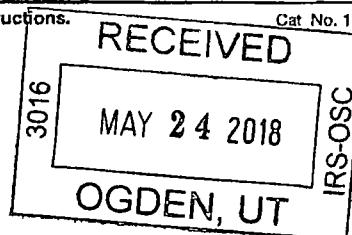

Form 990, Part VI, Section A, Line 1a:

The President, Vice President, Treasurer and Secretary serve as the members of the Executive Committee. Except for the power to amend the Articles of Incorporation and Bylaws, the Executive Committee shall have all the powers and authority of the board between board meetings.

Form 990, Part VI, Section A, Line 2:

All members of the board and the executive sponsor have a business relationship.

Form 990, Part VI, Section A, Line 6:

Membership shall be open to any current associate of Helzberg Diamonds that supports the purpose of the Organization. In order to become a voting member one must submit a signed Commitment Agreement to the Secretary and be active on a committee

Form 990, Part VI, Section A, Line 7a:

At the annual meeting the members shall elect the open directors and officer positions, each member shall be eligible to cast one vote

Form 990, Part VI, Section A, Line 7b:

In addition to electing the governing body and officers, members are entitled to vote on the Helzberg Helps Week theme and approval of grant recipients.

Form 990, Part VI, Section B, Line 11b:

The Form 990 is prepared by an independent accounting firm. A draft is then provided to the board of directors to review prior to filing with the IRS.

Form 990, Part VI, Section C, Line 19:

The Organization makes its governing documents and financial summary available to the general public upon request. At this time the

Organization does not have a formal Conflict of Interest Policy, but is in the process of reviewing and adopting a policy. Once the Conflict of Interest Policy is adopted it will be made available to the general public upon request.
