Foodshed Development WVFFC completed the first foodshed pilot in 2017, which included an aggregated CSA. The Coalition developed an assessment addressing Who the producers are in each county, available markets, restaurants, retail stores, infrastructure, transportation, technical assistance, training, and community development. A directory was produced in our annual magazine that includes food farm businesses across the state grouped by region as a resource for not only farmers, but also markets, restaurateurs, and consumers. The Coalition collaborated with the Try This WV staff to provide mini-grants to local communities to create more food access opportunities for low-income communities. The Coalition collaborated with WVU Food Justice Lab participating in their Nourishing Networks initiative a series of county-wide healthy food planning workshops. These workshops help counties look at their food security and brainstorm different solutions to enhance their communities access to healthy foods. We participated in these workshops to better inform future foodshed development work.

Form 990, Part III, Line 4c:

Beginning Farmer The WVFFC has continued to organize the WV Incubator Farm Network WVIFN, which includes monthly meetings and quarterly training with beginning farmer-training programs in WV. The WVIFN hosted a training with Rogue Farms Corps, in October 2017, focused on program structure and curriculum. The training was followed by a strategy session to develop the most effective and impactful training for beginning farmers that measures the skill level of trainees and translates across farms. The Network developed marketing materials that were distributed to each training program, local career at WVFFC events, and through social media. The Coalition developed a partnership with the WV Land Trust to create more land access opportunities for beginning farmers in the state and developed a plan to create a land access strategy in WV. The Coalition developed CRAFT Collaborative Regional Alliance for Farmer Training.
