The mission of the organization is to provide support for people with developmental disabilities, and their families. We do this by funding vocational, recreational, social, and health & welfare needs of people with disabilities and informational seminars for families.

We partner with PTOs of 9 local schools to sell school supplies kits to parents. Parents purchase online at DeerfieldCoalition.com. We purchase the school supplies wholesale & hire agencies with sheltered workshops to do the kit packing. Shore Training Center (Morton Grove, IL) and the Douglas Center (Skokie, IL) packed 2,218 kits in 2017. Approximately 25 clients of each sheltered workshop received vocational training and/or income for the programs in 2017. Volunteers run the rest of the program from sales/marketing/customer service to procurement/inventory management to delivery to schools.  
This program also provides free & reduced school supplies to students-in-need, through the schools & PTOs in four local school districts. Deerco collected \$2889 in online donations from parents for this purpose, and Deerco donated \$11,041 in product for this purpose.

We use the proceeds from our school supplies sale to fund programs for people with developmental disabilities, including:  
(1) We provide recreational and social events at no cost to attendees. Events include from 2-12 people. Events include going to the movies, mini-golf, gaming events, theme parks, attractions, entertainment, trips, arts & crafts, and lunch and dinner events.  
(2) We partnered with the local library to provided free informational events for parents & caregivers of adults with disabilities, with approximately 40 parents in attendance.  
(3) We subsidized work and recreational transportation at \$3 per trip.  
(4) We provided job training to high school students with disabilities who helped with school supplies packing & delivery.  
(5) We provided referrals, assistance, and coaching to students and adults looking for work and coordinated with local school district to hire students with disabilities in their maintenance department.

Proceeds also funded grants to organizations and individuals:  
(1) We provided grants of \$1000 each to North Shore Special Recreation Association (NSSRA) in Northbrook IL and Center for Enriched Living (CEL) in Riverwoods IL. Both organizations provide recreational and social programs for people with disabilities.  
(2) We provided grants of \$4,343 for individuals to attend programs at NSSRA, CEL, and the Deerfield Park District.  
(3) We donated \$839 in goods to the Deerfield Township Food Pantry.  
(4) We donated \$487 in goods to Toys For Tots.
