Completion of Phase 1 of YWAM Community Center and Campus in Battambang Cambodia, a facility with a classroom building that can accomodate up to 1,000 students, a cafeteria/meeting building that will accomodate up to 500 for meals and 1,000 for meetings; and 3 four story dorms capable of housing up to 72 students and staff. All funds donated are transmitted to the Cambodia entity University of the Nations of Battambang Cambodia, a registered Cambodian NGO certified to provide educational diplomas in English to student who compete the 12 level of classes which are given every quarter. It also provides voluntary educational training in Christian faith an discipleship as a separate educational program.

Staff and program support for Cambodians who carry out most of these programs; Approximately 2/3's of the staff are Cambodian locals who cannot otherwise work or provide for their families while carrying out the educational and community outreach programs in Battambang.

Support of specific outreach and training programs which continue to flourish, rund by a staff approaching 100 and serving about 400 -500 students in secular English and other educational programs and about 50 in voluntary faith-based educational and training programs. We also have community outreach to children-at-risk, women-at-risk, AID/HIV family support, village midwifery programs; etc. This year's expense was particularly highter because the Campus hosted a large regional YWAM conference in January 2017 with over 450 attendees from more than 15 countries in Asia.

Part 1, line 2: We maintain a close connection with the staff of U of N Battambang Cambodia as monies received by us almost always have a specific purpose, primarily building out of the large community center and educational campus, but also support of specific programs/staff: AID/HIV family assistance, women-at-risk, children-at-risk, educational programs for pre-school, kindergarten and after-high school classes for English (12 levels with government authorized certification on completion), computer, foreign languages, faith related education among others. In 2017 we also hosted one of the largest regional YWAM conferences in the world with over 450 participants coming for 2 weeks of training and education in community outreach, services and faith building skills. Substantiating records are maintained for all programs.

The other 51% was inherited by the President and both shares were placed into an LLC before sale so that there was no state excise tax on the sale of the non-profit's interest. The valuation of the property was based on the independent analysis of an experienced realtor, and the transaction between the Gustafson's and this non-profit was reviewed and approved by separate legal counsel for the Estate.
