The highlight of 2017 for this organization was the hosting of the 2017 Mowat-Wilson Syndrome Foundation International Family Conference in Washington, DC June 30-July 2, 2017 for the persons and their families affected by Mowat-Wilson Syndrome. Over 250 people attended this event coming from eleven different countries and 32 states. Drs. Mowat and Wilson, who discovered this rare genetic syndrome in 1998, flew in from Australia to present their lectures and meet the families. It was a highlight for many to meet and talk with them.

The conference provided 5 lectures, one of which was given by Dr. Jay Vivien, of Kansas City Medical Center. The MWSF has given \$20,000 in past two years to seed his basic research into Mowat-Wilson Syndrome. Dr. Vivien was able to present his findings at this conference as well. Multiple meals/social events were attended by families to meet and socialize and compare experiences in raising a child with Mowat-Wilson Syndrome. In addition, there were 8 workshops that provided information ranging from transitions to adulthood, bowel management, epilepsy and augmentative communication, to name a few. The conference was live-streamed on Facebook and videos of lectures and workshops were posted on our website, for those families that could not attend the conference. The conference was successful beyond our expectations!!!

MWSF continues to participate in partnership with Genetic Alliance in maintaining the MWSF PEER Patient Registry. There are three surveys that are available for families to complete. More surveys on specific medical topics on Mowat-Wilson Syndrome to be uploaded in 2018. The purpose of this patient registry is collect information related to this rare genetic syndrome to be available for researchers.

MWSF also participates in Rare Disease Day by attending state events and providing e-cards for families to post on social media. The MWSF also posts these e-cards on our social media and assembles a video set to music of all these children and adults' wonderful pictures. MWSF provides educational information to families through the website, [www.mowat-wilson.org](http://www.mowat-wilson.org) as well as Facebook, Youtube and other media, like newsletters.

The MWSF was genuinely surprised and thankful for being selected as the recipient of a \$10,000 donation from the TV show "Chopped," the Holiday Edition of Champions. Chef Adam Greenburg, named the MWSF as his charity of choice if he won the competition, which he did. His niece, Zoe Fineberg, was born with Mowat-Wilson Syndrome.
