ESSI expanded in 2017 to over 90 locations in Chin and Sagaing states and more than 2000 students. The Foundation provides an adaptable English language curriculum which is taught in the community mother tongue, stipends for teachers, and bi-annual teacher training intensives in which native English speakers are brought in for week-long English instructional intensives.

Mobile medical clinics were held in remote, under-served locations of Chin and Sagaing in which medical workers from Strait Clinic in Kalaymayo join medical workers from the US in health service provision.

Myanmar was the largest field of operation for the Foundation in 2016.

There were three recipients of Foundation education grants in 2017, including an MDiv candidate in a post-graduate theological studies program, a nursing student training as a missionary nurse, and a medical student.

4c (Code:) (Expenses \$ 48,568 including grants of \$ 48,568) (Revenue \$)Tanzania American Friendship Schools (AFS) and mobile medical clinics:

The AFS program included 15 schools and more than 200 students. The Foundation provides an adaptable English language curriculum which is taught in the community mother tongue. Mobile medical clinics were held in under-served locations in which medical workers from the US joined local Emergency Medical providers in health service provision.
