

In 2017, VVF consisted of 356 volunteers supporting a one week renovation project of a veterans center, 12 food distribution events supporting military & veteran families, 6 sporting events benefiting warrior athletes, 4 service maintenance projects & 2 patriotic celebrations for a local Veterans Elder Care Residential Facility serving 305 veterans, one book festival supporting aspiring veteran authors and military community readers, four holiday military & veteran family support events providing food, gifts & basic needs items for 270 families, one 3 day regional veteran homeless support event providing 100 supporters servicing over 1,000 homeless, one weekend of 100 supporters for local military patriotic & veterans memorial event, and serving as lead coordinating organization of one collaborative 6K Veterans Walk benefiting quality of life programs of elder veterans

In 2017, the LAA Team supported 12 Food4Warriors food distribution events of groceries supporting over 2,359 military, veterans and their families, provided groceries for a severely paralyzed veteran and his family, provided \$1000 worth of holiday gifts and festivities to a struggling wounded warrior and his family, provided gifts and basic needs items for 25 families at holiday event, and provided 270 families in need Thanksgiving & Christmas dinners
