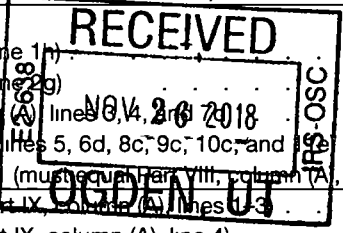

**Divestment**

Wrote a report showing that the City of Seattle's investments in fossil fuels caused it to forego almost \$100 million over a ten year period, and had almost 500 City employees sign a petition calling for their pension fund to divest from fossil fuels. We played a lead role in convincing the City to commit to breaking ties with Wells Fargo owing to its funding of the Dakota Access pipeline, and championed the passing of a public bank feasibility study.

**Movement Building**

Grew email list by 90%. Conducted monthly volunteer orientations and member meetings, regular trainings on organizing skills, action planning, outreach, and anti-racism, and took part in outreach at local businesses, schools, and festivals. Launched volunteer leadership team with 30 dedicated volunteers.

**Keep It In the Ground**

Organized at least one large event per month to raise awareness about fossil fuel projects such as PSE's LNG facility, Kalama Methanol, DAPL, Vancouver oil by rail, and Anacortes xylene. Encouraged people to take action now to address climate change. Event participation ranged from hundreds to over one thousand. Held a PSE regional day of action with 14 groups participating.
