Journeys of Compassion Impact Nations conducted 8, 10, and 12 day mission trips in 2017. We took teams of 10-25 volunteers to Haiti, India, Nepal, Kenya, Uganda, and the Philippines. On these trips, the teams helped in medical clinics, distributed water filters, provided education in health and sanitation, and taught local pastors and leaders. The teams also led in many evangelistic meetings, conducted door to door evangelism, and baptized new Christian believers.

4b (Code:) (Expenses \$ 26,000 including grants of \$ 26,000) (Revenue \$ 26,000)

Disaster relief was provided in Puerto Rico in response to hurricane Maria. Three small teams were sent to Puerto Rico to distribute medicine and water filters. Impact Nations partnered with others to install approximately 3,500 Sawyer water filters to families who were without access to safe drinking water. In addition to bringing filters to thousands of homes, several community water stations were established to serve larger groups of people.

School of Purpose A vocational school was established in Kampala, Uganda. The school serves teenage girls who have become pregnant as a result of sexual abuse. Twenty girls graduated from the program in 2017 and many of them have since found employment and are able to support themselves and their babies.
