



Produce to the People Produce is distributed at No Cost to the participants.
A Program that distributes fresh produce and nutritious food to members of our community through weekly markets These farmer's market style distributions run year-round, allowing the consistent and reliable access to healthy food for those facing food insecurity The thousands of pounds of food that are distributed each week come from the collaboration and partnerships with Manna Food Bank, local farmers, growers, community gardens, and grocery stores. This year approximately 354,444 lbs of fresh produce was distributed to 9,279 households (28,448 participants) at 255 markets
A 2017 UNCA health & wellness survey indicated a) an increase in food security - identified by respondents reporting a reduction in the number of meals they skipped due to access to the fresh produce, b) respondents reported increasing their consumption of fruits and vegetables as a result of this access.

Rooted in Health All classes & support are available to participants at No Cost.
A program using an evidence based whole person health model that provides education and resources to address the emotional, spiritual and physical health & wellbeing of those participating. Weekly interactive and participatory health, wellness, & nutrition classes, cooking demonstrations providing recipes & handouts, yoga & exercise classes, as well as individual and group health coaching are offered. Bounty & Soul creates a supportive and safe environment in which positive changes in diet and lifestyle are built on relationship and trust. Approx 6,200 people engaged in the 415 yoga, exercise, and health & wellness classes provided The 2017 UNCA health & wellness survey respondents reported, increased knowlege in healthy eating, increased physical activity and energy; improved overall health; reduced medication taken; improved ability to manage stress; improved/reduced weight.

Health Coaching element: 100 people attended 48 group classes and 16 individuals engaged in a 3-month cohort based program.
Reported results: weight loss in those seeking weight loss; reduction of A1C in clients w/pre-diabetes & diabetes, decrease in blood pressure & cholesterol in; reduction of stress, anxiety, & depression

Latinx Engagement Program: All classes & support are available to participants at No Cost
A unique program addressing the needs and gaps in service that exist in the Latinx community, as identified through discussion and dialogue with the community The program includes English as Second Language classes, health & wellness classes delivered in Spanish, recipes highlighting healthy foods translated into Spanish, culturally appropriate cooking demonstrations, Zumba classes, and access to specific community resources are offered weekly.
Zumba: approximately 780 total attendees in 51 classes
ESL: approximately 350 total attendees in 45 classes
Health & Wellness: approximately 500 total attendees in 50 classes
