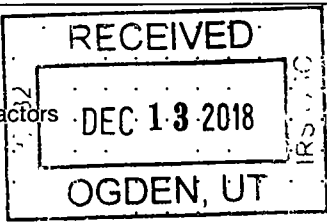

Explanation of "Other Expenses", line 16 of Form 990-EZ: The L3 Foundation purchases and sells merchandise containing the L3 logo to encourage awareness of our organization and for name recognition in the community. The L3 Foundation leases a storage unit for a minimum monthly fee to store the merchandise.

Explanation of "Grants & Similar Amounts Paid", line 10 of Form 990-EZ: The L3 Foundation gave \$110,000 to Texas Children's Hospital located at 1102 Bates Street, Suite 1570, Houston, Texas, 77030. The purpose of this donation was continued assistance with the financing of a project to develop an effective immunotherapy for rhabdomyosarcoma (RMS), a soft tissue cancer. The L3 Foundation was named in honor of Landon Ahrendt who passed away at the age of 10 from rhabdomyosarcoma. In addition, a donation of \$10,000 was also given to Texas Children's Hospital as a donation for parking tokens to be used by family members of patients at the hospital. Additional donations totaling \$10,344 were given to various cancer patients and families requiring assistance.
