Farm to School Program - This initiative allows students to meet weekly with a Farm to School coordinator who teaches our youth to plant, water, weed and learn about growing their own organic food for sustainability purposes as well as healthy eating habits. The students integrate math and science concepts which include growth areas and square footage by plant type, measuring both plant growth and rainfall, calculating time needs for harvesting vegetables while learning the role nature plays in the process of growing food both positive and negative. Aquaponics has been introduced to the schools throughout the county as well. This teaches our youth to grow food and fish without soil in a very small area. Aquaponics is the most sustainable form of gardening and is easily adopted in our marine environment of the Florida Keys.
