Next, CBISA is the gathering, collecting, and reporting of all data relating to community benefit activities and programs across the System. A CBISA is conducted every year by each hospital according to the following steps: - Collect and enter data. Kick-off meeting conducted and updated toolkit distributed, new staff complete Lyon web-based course, and periodic meetings scheduled to evaluate and monitor progress. Emails sent reminding staff to submit activities, occurrences entered into Lyon, and reports are produced and shared with leaders. - Finalize and report on prior year. All prior year data entered into Lyon by January 31, and communicate final prior year figures to IRS, System Board, and the community. System Office staff and leaders oversee and monitor SSMH's Community Benefit Program, and ensure reporting is in compliance with IRS regulations. In collaboration with community stakeholders and partner organizations, all hospital CHNAs were completed, approved, and integrated into the organization's strategic plan. We continue to monitor and assess the progress of our local efforts in the spirit of caring for others and improving community health. In collaboration with our community partners, most SSM Health hospital facilities completed their most recent cycle of the CHNA in 2015. The assessments were approved.</p>
