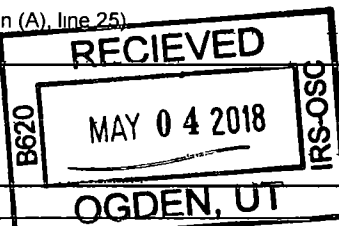

Provided inpatient and outpatient renal dialysis primarily to residents of southeast Nebraska. At the end of FY 2017, the Dialysis Center of Lincoln had more than 200 patients. During the short period reported, the Dialysis Center provided more than 12,000 outpatient hemodialysis treatments, and almost 1,800 dialysis treatments were provided to hospital inpatients. In addition, the Dialysis Center participates in research programs related to kidney disease and treatment. Employees are encouraged to participate in local and national organizations which foster advancement in renal dialysis.
