We have developed programs that utilize state-of-the-art IT tools to help our educational and non-profit partners fund, manage, and evaluate their programs. With our assistance they are able to build capacity, empower themselves, and realize their full potential. We equip them with the skills necessary to be innovative, build leadership, and ultimately fulfill their mission.

This group also includes our grant consulting services, Aria software service, and Hatchfund.org service.

Hatchfund.org provides technology administration for public contribution to artistic programs. Hatchfund artists served in 2017 were 153, while 7 institutions utilized our Aria software in 2017.

AIM helps develop a skilled IT workforce necessary to grow and support our local and state economies now and in the future.

Core to our mission is getting young people interested in, aware of, and pursuing educational and career opportunities that follow an information technology path. It is our firm belief that building the K-20 pipeline of talent will allow individuals to generate economic prosperity through the imaginative use of emerging technologies. Our Talent Search, Upward Bound, and Educational Opportunity Center programs are among the programs in this service group.

The number of individuals served in our Building a Strong Workforce programs in 2017 is estimated to be 10,120. The number of individuals converted to IT careers in 2017 as a result of our programs is 535.

AIM recognizes that top talent must be recruited and retained for regions to remain economically successful. Careerlink.com also provides career development and educational resources to Nebraska schools and students with special emphasis on technology careers.

Careerlink IT career connections in 2017 were estimated to be about 1,200.
