The purpose of Fallen Patriots grants is to cover the costs associated with college tuition, student loans, room, board, living expenses, books fees and other miscellaneous educational expenses. To monitor the use of grant funds, the following controls are in place: Potential grant recipients are verified through Department of Defense casualty next of kin lists or through review of Form DD 1300. Recipient needs are reviewed with the Program Director and reviewed by the Chief Executive Officer prior to distribution of funds. Funds are distributed directly to the college or university to be applied to the student's expenses whenever possible. Receipts are used for direct reimbursement to students or their surviving parent. Minimum fixed funding amounts are provided for living expenses, transportation, books, and one-time computer purchases. These fixed amounts are based in part on third party expense studies provided by the college board. These amounts also are corroborated by Fallen Patriots cost/expense experience over fourteen years.
