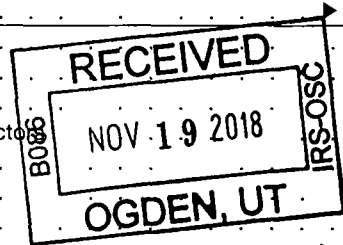



Compassion Project to Albuquerque. The compassion project is a meditation program aimed at giving caregivers a means of renewal in
