AMURTEL works with women and children struggling to survive, by providing education, medical care, options for food security such as training in improved farming techniques, and offers micro credit, self-help groups, literacy training, etc, to help women become financially stable. Our approach is to partner with and empower those we work with, encouraging self-initiative and self-determination. We also provide immediate relief to families in the form of food, water, & medical care after a disaster.

In Haiti, Amurtel sustained our program for over 1000 teenage girls living in poverty, support additional women to join our Micro Credit program, enroll another 200 women in our Self-Help program, added more children to our orphanage and provide medical care and nutritious food for many mothers of young children. Our staff offered classes in literacy, small scale industry and agronomy to many families, both in Port au Prince, and in the Anse a Pitare region. Follow-up for hurricanes of the previous year's hurricane continued, and all three schools were able to increase their enrollment for children living below the poverty line.

USA Disaster Relief- Due to the devastation from Hurricanes Harvey, Irma, and Maria, Amurtel was extremely busy providing aid to hundreds of victims. We created a special program for providing solar outreach systems to residents of Puerto Rico, who faced months with out power.

In Greece Amurtel continued to support the work of the program for mothers and babies. An ultrasound machine was purchased, additional staff were hired, including trauma counselors, and radiologists. Nutritious pre and post natal supplements were provided to hundreds of young mothers, along with welcome kits for new families, which included diapers, baby clothes, baby carriers, bassinets, and a soft toy for the new baby.
