1) BEST HEART CARE IN EAST HAWAII BEST HEART CARE IN EAST HAWAII WAS AN AMBITIOUS PROJECT TO COORDINATE PATIENT CARE ACROSS THE CONTINUUM OF CARE FROM THE EMERGENCY ROOM (ER) AND HOSPITAL ADMISSION TO PRIMARY CARE AND NON-MEDICAL NEEDS. THE PROGRAM SOUGHT TO COORDINATE CARE FOR SOME OF THE COMMUNITY'S MOST CHRONICALLY ILL PATIENTS. PATIENTS WERE CHOSEN FROM THOSE WHO WENT TO THE ER AND HAD A DIAGNOSIS OF CHRONIC HEART DISEASE. RESOURCES TO IMPLEMENT THE PROGRAM WERE POOLED BY HOSPICE OF HILO, EAST HAWAII INDEPENDENT PHYSICIAN'S ASSOCIATION (EHI), HILO MEDICAL CENTER, NATIONAL KIDNEY FOUNDATION OF HAWAII, AND HMSA (LARGEST HEALTH PLAN IN THE STATE). BEST HEART CARE IN EAST HAWAII WAS SUCCESSFUL IN CREATING A REFERRAL PROCESS FOR PARTNERS TO FACILITATE PATIENT CARE AMONG ALL PROVIDERS. RECOGNIZING THE BROADER NEED AND CHANGING RESOURCE BASE, BEST HEART CARE IN EAST HAWAII WILL TRANSITION TO BEST PALLIATIVE CARE IN JANUARY 2017. THE INITIATIVE WILL ALLOW STAGE 3 AND STAGE 4 HEART DISEASE PATIENTS AS WELL AS PATIENT WITH TERMINAL CANCER DIAGNOSES. HOSPICE OF HILO WILL PROVIDE THE ORGANIZATIONAL LEADERSHIP, BUT THIS WILL REMAIN A COMMUNITY FIRST PRIORITY INITIATIVE.

2) BLOOD PRESSURE EDUCATOR PROJECT COMMUNITY FIRST AND UNIVERSITY OF HAWAII AT HILO SCHOOL OF NURSING (SON) ARE EAGER TO CONTINUE THIS PROJECT. IN THIS COLLABORATIVE COMMUNITY EDUCATION PROJECT, SON STUDENTS IN THE FINAL SEMESTER OF THE DEGREE PROGRAM TEACH LOCAL FIFTH AND SIXTH GRADE STUDENTS ABOUT THE DANGERS AND PREVENTION OF HYPERTENSION (HIGH BLOOD PRESSURE). EAST HAWAII IPA, UNIVERSITY OF HILO OF HAWAII SCHOOL OF NURSING, KTA SUPER STORES, AND ELEMENTARY SCHOOLS ARE ALL EXCITED TO KEEP THIS PROJECT GOING. IN THE NEXT COHORT, COMMUNITY FIRST WILL EXPLORE PARTNERING WITH THE HAWAII COMMUNITY COLLEGE NURSING PROGRAM. THIS EFFORT WILL EITHER SEEK TO ENGAGE MORE SCHOOLS OR TO BEING EDUCATING LOCAL EMPLOYERS. IN 2017, APPROXIMATELY 200 STUDENTS PARTICIPATED.

3) ORNISH CARDIAC REHAB AT HILO MEDICAL CENTER AS OF JULY 2017, HILO MEDICAL CENTER HAVE TENTATIVELY AGREED TO PLACE AN ORNISH CARDIAC REHAB PROGRAM IN HILO. HMC WILL NEED TO ENROLL OVER 100 PATIENTS FOR THE PROGRAM TO BE SUSTAINABLE. COMMUNITY FIRST WILL CONTINUE ADVOCATING FOR THE PROGRAM AND WILL ACTIVELY ENGAGE IN PROMOTING THE PROGRAM THROUGH OUR NETWORK OF PARTNERS.
