4a (Code:) (Expenses \$ including grants of \$ 162,600) (Revenue \$)
Financial support provided to Tumaini Childrens home, a non-profit corporation in Eldoret, Kenya. Funds were used to provide for the daily needs of 33 orphaned children, including food, clothing, shelter, education, and medical care. A new home for the children was constructed to adequately house and care for the children, as required by the Kenyan government. Donations funded construction of the new home. Children and staff began using the facility in December and then made the total relocation in January of 2018. The home is managed by missionaries Horace & Phyllis Leister. They employ a staff of 11 Kenyans to provide round-the-clock child care, run an accredited home school, prepare meals, and perform household chores. Kenyan employees also now assist with farm chores associated with raising produce consumed by the children and workers. The only expenses associated with Tumaini Childrens Home in beyond construction costs and ongoing home expenses were wire transfer fees paid to send funds from the US to Kenya. Family Keys will continue to support Tumaini Childrens Home in coming years. The new home will be finished and a new school building will be constructed on the grounds of the new home.

4b (Code:) (Expenses \$ including grants of \$ 25,115) (Revenue \$)
Financial support provided to missionaries Horace & Phyllis Leister and their daughter, for subsistence and personal needs. Funds for Tumaini Childrens Home can not be used for the personal expenses of Horace & Phyllis Leister or their daughter, per rules of the Kenyan government and guidelines of the Childrens Home non-profit organization. Funds were used for food, clothing, medical expenses and personal expenses. Family Keys will continue to support Horace & Phyllis Leister in coming years.

4c (Code:) (Expenses \$ including grants of \$ 30,055) (Revenue \$)
Financial support provided to missionaries Josh and Rachel Leister. Josh is a surgical assistant at a mission hospital in Kapsowar, Kenya. Wife Rachel is a nurse, but also helps manage home schooling for the Leister children and other children at the mission hospital site. Funds provided by Family Keys were used for the Leisters' food, clothing, purchase of a vehicle and vehicle operating costs during the travel and medical expenses, as well as personal needs. Family Keys will continue to support Josh and Rachel Leister in coming years.
