School sponsorships for orphans and other children in need. Over 300 children were sponsored for this past school year in Ethiopia. Also support of the orphan homes and family sponsorships. Included are site visit expenses to serve at the schools and orphan homes.

Providing start up funds for micro-businesses or small farms to be operated by families or individuals previously being sponsored by Ethiopian NGOs. With that support being their main means of subsistence. The first micro business aided was a weaving operation that is now operated by single mothers making blankets and scarves. Additional support has been provided to small scale agriculture operations and small retail shops to sell spices and vegetables made or produced by adults formerly being sponsored financially.

Advocacy for local foster care and adoption needs through family recruitment and partnering with local govt. and other agencies. Activities included small and large group meetings.
