Artists of all ages and skill levels are encouraged to learn more about native plants, and animals and depict these species in the media of their choosing. The exhibition features works from elementary students to renowned local artists and is open for public viewing for one month. The program reached 2,139 in 2017 via the art exhibition and its associated events including art hikes, school art presentations, and workshops, exhibit tours, and school activities.****4c** (Code: ) (Expenses \$ **347** including grants of \$ **0**) (Revenue \$ **0**)**The Kauluwehi program promotes native forest engagement and awareness through hands on workshops and events that incorporate Hawaiian culture and native species. Through lei and wreath making workshops participants visit native forests, learn sustainable picking practices, decontamination techniques to prevent invasive species, and work with cultural practitioners. Two workshops were held in 2017, and 34 people participated.
