Food distributions included 32,000 pounds of fresh produce and 17,000 pounds of meat and dairy having very positive impact on the health of our guests. We distributed complete Thanksgiving baskets including whole turkey, fresh potatoes and pies to 227 families feeding 698 individuals. We provided simple recipes so our guest could incorporate healthy foods into their meals. We also distributed clothing, household goods, backpacks, grocery carts, Easter baskets, hats and mittens, and Christmas gifts to families who did not have gifts for their children. We connected our guests through 1000's of referrals with other agencies to meet other crucial needs. Provided limited emergency cash grants as assistance to individuals for utility, transportation, or housing needs.
