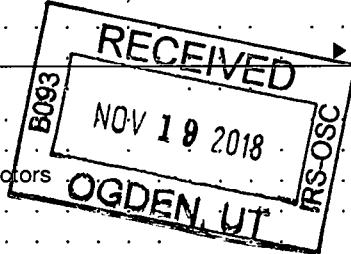



That role was refined to specialize in aiding women with metastatic breast cancer which eventually occurs to one in three people with a breast cancer diagnosis and is fatal.
